Snow Removal: Please place your garbage out after plowing, as the plow usually goes out very early in the morning. As a courtesy, please keep vehicles and garbage/recycle cans off streets during winter months to help with snow removal. Do not remove your snow from driveways to the village streets. **Between November 1st & April 15th, no parking in Village streets or alleys between 1:00 am and 7:00 am per Ordinance 2019-1.**

NOTE: DO NOT COMBINE UTILITY BILLS AND DOG LICENSE FEES WITH YOUR CHECK FOR TAXES. PLEASE WRITE SEPARATE CHECKS FOR EACH BILL. FOR CASH PAYMENTS, PLEASE HAVE EXACT CHANGE.

Real Estate Taxes: Can be paid in 2 installments; 1st installment is due and must be in my hands by February 5th, 2022. The next installment is to be paid to the Rusk County Treasurer at the Courthouse or by mail by July 31ST, 2022. The amount due will show on your tax statement.

Personal Property Taxes must be paid in full and received by the Village or the County on or before February 5th, 2022. (Postmarks will not be accepted).

First Dollar Credit has been added just above the Lottery and Gaming credit line on the Property Tax Bill. This is given on all bills that show improvements and will be distributed in two installments. The Dollar Credit does not apply to Personal Property.

DOG OWNERS: EVERY dog in the Village of Weyerhaeuser MUST BE VACCINATED FOR RABIES (THIS IS STATE LAW) and LICENSED. YOU MUST BRING PROOF OF VACCINATION(S) WITH YOU WHEN YOU COME FOR THE LICENSE/LICENSES. Those who do not have updated proof of vaccination(s) or do not purchase the license(s) here at the Village Hall will have their names turned over to Rusk County for further action. Costs: \$7.50 neutered/spaded, all others \$10.00.

Village Treasurer Hours for Tax Collection:

Village Hall is open **Wednesday, 9:00 AM - 5:00 PM and Thursday & Friday 9:00 am – 1:00 PM**, located at N3723 2nd Street. Payments may be mailed or dropped off at the outside box located at the Village Hall, or in person if the office personnel are there. No receipts will be sent unless a stamped self-addressed envelope is provided with payment. If you cannot make these dates please call 715-353-2571, leave a message and I will call you back to make other arrangements. Christmas Eve Day, Christmas Day, New Year's Eve Day, and New Year's Day the office will be closed.
