- DNR LOAN FOR PROJECT 20-150. Require Board action on one of two options in order to move forward with the loan closing for June as a suspense date. 1st option would be to use TIF funds to pay off the RD loan of approx..\$162,500. This would clear up village debt enough to take out the DNR loan to obtain the 60% principal forgiveness for the project. The second option is to increase our utility rates set to increase May of 2022 with a new resolution.
- Railway Ave project awarding of contract on project set to start in June of 2022.
- Will Zimmerman water line issue and the bill he sent to Tom Bush
- Harden asked if the village was going to remove the trees on the lot line of her property and the village property at W14416 and W14418 Railway Ave. If the village is going to remove them, she asked if the village would remove the row of trees on her side of the lot line.
- Village of Bruce sent a letter asking for a donation of \$171.81 for the Bruce Ambulance services.

- Barb Z. asked for the board to decide on when the basketball hoop on her property could be fixed. She stated that the basketball hoop was hit by the dump truck a few years ago when they repaved the street. She just wants the hoop fixed.
