

VILLAGE ORDINANCE

No. 8.

An ordinance providing for the licensing of transient merchants, hawkers, and peddlers.

The Village Board of the Village of Weyerhaeuser do ordain as follows:

SECTION 1.

No person required by the laws of the State of Wisconsin to obtain a license for the purpose of engaging in the business or occupation of a transient merchant, hawker or peddler, shall engage in or follow the business of a transient merchant hawker or peddler, within the corporate limits of the Village of Weyerhaeuser, without first having paid to the Treasurer of said Village the fee or fees herein after provided.

SECTION 2.

Every transient merchant before commencing business as such in the Village of Weyerhaeuser, shall pay to the Treasurer thereof the sum of \$5 per day for each day that he may engage in carrying on such business.

Every hawker or peddler before doing any business as such in the Village of Weyerhaeuser shall pay to the Treasurer thereof the sum of \$5 per day for each day that he may engage in carrying on such business.

SECTION 3.

Upon the payments mentioned in Section 2 being made, the Village Treasurer shall give a receipt showing the amount and for what received and the Village Clerk upon presentation of such receipt shall issue a license to the applicant to carry on the business of transient merchant, hawker or peddler as the case may be for the number of days for which payment has been received.

SECTION 4.

If complaint be made to the Village President that any person doing business therein is a transient merchant, and such person shall claim to be a permanent merchant, he shall be required as a condition of transacting business in the Village of Weyerhaeuser, without payment of said license fee to the Village, to give a bond to the Village to secure the payment of the State and local fees, in the event that he fails to become a permanent merchant under the laws of the State of Wisconsin, in the penal sum of \$100 with securities to be approved by the Village President, which bond shall be enforced in case of breach thereof, by the proper officers of the Village, and the proceeds applied as required by law.

SECTION 5.

If any person shall violates any of the provisions of this ordinance, if a transient merchant, an action may be brought in the name of the Village of Weyerhaeuser against the person so offending to recover the amount of the per diem tax unpaid and the costs of action, and upon conviction thereof such person shall be adjudged to pay a fine of not less than \$25, no more than \$50 and the costs of prosecution and to be

imprisoned in the County Jail of Rusk County, until said judgment be paid, not exceeding, however, the term of sixty days.

If any person violating any of the provisions of this ordinance be a hawker or peddler an action may be brought as above specified and upon conviction such person shall be adjudged to pay a fine of not less than \$10 nor more than \$25 and the costs of prosecution, and to be imprisoned in the County Jail of Rusk County until such judgment be paid, not exceeding, however, the term of thirty days.

SECTION 6.

This ordinance shall take effect and be in force from and after its passage and publication.
