ORDINANCE 2019-1
WINTER PARKING REGULATIONS

1. INTRODUCTION:

In order to facilitate the efficient and expeditious plowing of snow in the Village streets, alleys, and roadways during winter months, Winter Parking Regulations are enacted as follows.

2. WINTER PARKING:

Between November 1st and April 15th of each winter season, no person shall park or leave standing any vehicle on any street, alley, or roadway in the Village between the hours of 2:00 a.m. and 7:00 a.m.

a. Towing of Illegally Parked Vehicles

- i. First offense for any vehicle in violation of this Section during each winter season shall be issued by the Public Works Director or his employee, a penalty of Twenty-Five dollars and no/100 Dollars (\$25.00), payable to the Village Clerk/Treasurer at the Village Hall.
- ii. Second offense for any vehicle in violation of this Section during each winter season shall be issued by the Public Works Director or his employee, a penalty of Fifty and no/100 Dollars (\$50.00), payable to the Village Clerk/Treasurer at the Village Hall.
- iii. Third offense for any vehicle in violation of this Section during each winter season shall be issued by the Public Works Director or his employee, a penalty of Seventy-Five and no/100 Dollars (\$75.00), payable to the Village Clerk/Treasurer at the Village Hall, and the vehicle impounded until lawfully claimed. Actual charges for such towing and removal may be assessed against the driver or party responsible for the violation in addition to any other penalty which may be provided for the violation of this section. The towing charges shall be paid by the owner to the towing firm before the vehicle is released from the impound area. In the event that the owner of the towed vehicle removes the impounded vehicle from the impound area without first paying the towing charges, the owner shall be subject to an additional forfeiture for violation of this Section. Such forfeiture shall not be less than the cost of the towing charges and any other additional charges as a result of this violation.

3. EXEMPT VEHICLES:

The provisions of this chapter regulating the parking and standing of vehicles shall not apply to authorized police, emergency, or Village public works maintenance vehicles.

4. DEPOSITS IN STREETS RESTRICTED:

No person shall cause to be deposited snow from his premises onto the sidewalk abutting thereon or onto any street, alley, or roadway in the Village without a permit therefor from the Public Works Director or his employee, who may require payment of a fee sufficient to reimburse the Village for the cost of removing any snow so deposited.


5. EFFECTIVE DATE:

This ordinance shall take effect and be in force from and after passage and publication.
